### **6. ACCIDENTAL RELEASE MEASURES**

Personal precautions, protective, equipment and emergency procedures: (Methods and materials for containment and cleaning up) Eliminate all sources of ignition. Avoid contact with skin or inhalation of spillage, dust or vapor. Keep unnecessary personnel away. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing.
