6. ACCIDENTAL RELEASE MEASURES

Personal precautions, protective, equipment and emergency procedures: (Methods and materials for containment and cleaning up) Eliminate all sources of ignition. Avoid contact with skin or inhalation of spillage, dust or vapor. Keep unnecessary personnel away. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ventilate closed spaces before entering them. Collect and dispose of spillage as indicated in section 13 of the SDS.
